TERMS AND CONDITIONS

1. Interested parties (***Only Authorised Scrappers of motor vehicle in Delhi***) may inspect the car on scheduled dates and satisfy themselves about the car they are bidding for.
2. Acceptance of the terms & conditions in the bid form after inspection of the vehicle & confirmation for participating in the auctioning should be addressed to the Administrative Officer, 17-B, Sri Aurobindo Marg, New Delhi-110016.
3. Duly signed auction bid/document along with a copy of identity and address proof placed in a sealed cover must reach the Administrative Officer, NIEPA, New Delhi latest by November 30, 2022 up to 02.00 PM. No late bids will be considered.
4. Interested parties may visit the Institute's office block on any working day between 10.00 AM to 4.00 PM.
5. The bid should be accompanied by an Earnest Money Deposit (EMD) of Rs. 30,000/- drawn in favour of (***Finance Officer, NIEPA***) New Delhi. No interest shall be paid on the EMD. EMD of all the unsuccessful bidders will be refunded after award of the order to highest bidder and the EMD of the Successful bidder will only release after deposit of full amount, as quoted by him/her, in NIEPA's account and submission of copy of Registration certificate in Serial no. 6. In case the vehicle is not lifted within 30 days of the award letter, the institute reserves the right to forfeit the EMD of the defaulter and sell the car to the next highest bidder.
6. The successful bidder has to make full payment in form of cheque on completion of the auctioning in favour NIEPA, New Delhi and the vehicle shall be delivered on realization of the cheque. If the cheque fails to realize, the offer will be cancelled and EMD shall be forfeited. EMD amount will not be adjusted as payment.
7. The successful bidder shall be required to pick the car from the disposal site to his premises within three days after the realization of the payment at his own expense.
8. The car, once, disposed to the successful bidder, shall not be taken back by NIEPA, on any condition whatsoever.
9. The bidder will issue a Scrapping Certificate after scrapping of vehicle to the registered owner. A cut piece of Chassis Number also will be submitted in the Institute.
10. The bids will be open on November 30, 2022 at 2.30 PM in the presence of all the participating bidders.
11. NIEPA reserves the right to cancel the auction without assigning any reason whatsoever.
